2. The monthly Vehicle Patrol service fee will be added to existing **ADT**'s Armed Response fee. (the existing debit order will be adjusted accordingly).
3. It is required that all clients sign an **ADT** contract and a monthly debit order authorization, to the value of R500,00\_ (FIVE HUNDRED RAND)\_ inclusive of vat, per member, per month, to participate in the above services.
4. The service fee will remain fixed for a period of 12 (Twelve) months from commencement date, after which increases will be negotiated with Craigpark Residents Association.
5. Should the number of contributing members drop below, and remain below, 550 (five hundred & fifty)\_ contributing members, **ADT** reserves the right to reduce the level of service according to the amount of contributions received or increase the monthly Vehicle Patrol contribution.
